Watering Restrictions

Well, the sustained hot, dry weather is upon us. As you know from the signs at the entrances to the neighborhood, we are currently in Stage 1 watering restrictions which are automatically enacted on May 01^{st} of each year. While in Stage 1, your HOA Board respectfully asks that you comply with the requirement to not water your lawn between the hours of 10 am and 7 pm. Also consider reducing water usage for cleaning driveway, washing vehicles, filling ornamental fountains, etc. Below is a partial synopsis of the ordinances covering Stage 2 water restrictions for the Town of Northlake as it applies to lawn watering.

Stage 2 through Stage 4 are also mandatory restrictions and hopefully these measures will not have to be enacted for a

long time, if at all, but if they are please remember that non-compliance subjects the violator to a fine (citation by police) and/or the possible temporary suspension of water service by the Town of Northlake. Yes, the Town does have the authority to turn off your water to stop the ordinance violation however such a measure would only be undertaken by the Town of Northlake Public Works after making every reasonable attempt to contact the homeowner or other known person who could immediately stop the illegal use of water. There are numerous other provisions to Stage 2 watering restrictions which can be found by going to the Town website at www.town.northlake.tx.us however lawn watering seems to be the most common violation and your HOA Board wanted to make sure you were aware of this restriction.

Stage 1, Water Awareness

Annually, beginning on May 01st through September 30th; Water customers are requested to voluntarily reduce water use, to practice water conservation, and to minimize water use for nonessential purposes. Watering your lawn is not allowed from 10 am to 7 pm.

Stage 2, Water watch

In addition to the requirements of section 12.08.012 hereof, limit landscaping watering at each service address to only twice every week.

The Town of Northlake will be going door to door to provide you with the proper notification and instructions as to what steps will be required by you to ensure that the new service and lines are free of all contaminates before you use it.*
