Architectural Control Committee (ACC)

Members of the ACC, under the direction of the HOA Board, serve 2 year terms and can be reappointed until they resign or are removed by the HOA Board. This committee is responsible for timely online review of homeowner requests for new structures such as adding a fence, an outbuilding or a pool, or other major landscape improvements to ensure assure the appearance of each property continues to enhance the value of the entire development. They are familiar with the HOA Covenants, Conditions, & Restrictions and the committee may on occasion meet independently or jointly with the HOA Board. -Contact Spectrum if you would like to serve on this committee the next time a member is selected. Town of Northlake Golf Carts Ordinance No. 09-1210A

We know many of you would like to know the real facts-on the golf cart ordinance.so here they are in print for you. They are 4 pages long, so we have taken the liberty of only printing the part that pertains to North Ridge Estates roadways. For the homeowners who that do not have a golf cart, we apologize for taking up so much space in this newsletter.

Sec. 101.1102 Requirements for Golf Carts which are to be operated on Public Roadway.

No person may operate a golf cart upon a public roadway within the Town of Northlake as permitted by this Article, unless the golf cart is equipped with each of the following:

- a. Headlamps meeting the requirement of Chapter 547 of the Texas Transportation Code if the golf cart is operated after sunset and before sunrise, as defined in the Texas Transportation Code Section 541...401;
- b. Tail lamps meeting the requirement same as above.
- c. Reflectors meeting the requirement same as above
- A parking break meeting the requirements of chapter 547 of the Texas Transportation Code;

- e. Mirrors meeting the requirements of chapter 547 of the Texas Transportation Code
- f. A slow-moving vehicle emblem meeting the requirements of Chapter 547 of the Texas Transportation Code.

Sec. 10.1103. Insurance.

Any person, who operates a golf cart upon a public roadway within the Town of Northlake, as permitted by this Article, shall maintain financial responsibility as required of other passenger vehicles in the Texas Transportation Code Section 601.051.

Sec. 10.1104. Other Restriction on Golf Cart Operation.

The following addition restriction shall apply to the operation of any golf cart in the Town of Northlake, as permitted in this Article:

- Golf carts shall not operate at a speed greater than 20 miles per hour;
- Each operator of a golf cart shall possess a valid driver's license, as required of operators of other passenger vehicles in the Texas Transportation Code, Section 521.083:
- c. Operators of golf carts shall not allow anyone to sit in the lap of the operator or passengers of the vehicle, nor allow anyone to stand up in the vehicle during the operation of the vehicle.

 Passengers shall be limited to the seating capacity as designed by the manufacturer; and

 Golf carts shall not be operated within a city park.

Sec.10.1105. Permissible Operation of Golf Carts

Unless otherwise permitted by the Texas Transportation Code, Section 502.0071, a golf cart meeting the requirements of this Article may be operated by person meeting the requirements for an operator of such golf cart as set forth in this article only upon the following public roadways, and only upon such portion of said roadways having a posted speed limit of 35 MPH, or less, within the Town of Northlake:

Canyon Ridge Drive, Clover Ridge
Drive, Pine Ridge Drive Meadow Ridge
Drive, Vista Ridge Drive, Hill Ridge
Drive, Stone Ridge Drive, Willow Ridge
Drive, and Valley Ridge Drive

A golf cart may not be operated upon any other roadway within the Town of Northlake, unless such operation is permitted by the Texas Transportation Code, Section 502.0071.

In order to stay up to date with the community, be sure your email address is registered with Spectrum. -Register your email address at www.spectruman.com to receive official HOA group email updates. Add spectruman@cincsystems.net to your contact list to assure emails are not blocked by your spam blocker. CINC is Spectrum's system that you log into to review your account. CINC will only pull from the emails that are registered by the homeowners. Encourage your neighbor to the left and right of you to also-register too. The Board will assure you that Spectrum will never sell or give your email address to anyone.

We have also made some changes to the Spectrum web site to make it easier to locate the current CC&Rs. Across the top information bar you will see a button for DCC&Rs, also check out the COMMUNITY INFO that has all been corrected as well.

Please be Advised

-It is prohibited to post signs on HOA property at the entrances on Hwy 407 and Florence Road, this also includes any HOA common property.

Due to liability issues, it is not permissible for anyone to build or place any type of structure on HOA property, including play forts. -The unplanned removal expense generally comes out of your annual budget unless the homeowner involved is identified, in which case the fine and expenses incurred will be assessed the individual homeowner.

Be Thoughtful

Mail cannot be delivered if the postal carrier cannot access a mailbox from the mail vehicle. Avoid parking near or in front of mail boxes.

Required Trees in Front Yard

Trees thrive best when planted during cooler weather, so Fall is the best time to plant trees in North Texas. The Declaration of Covenants, Conditions, and Restrictions require that homeowners plant at least 2 trees in their front yard. Section 3.6(a) states: all Lots with a Residence thereon shall include at least 2 trees with 3" caliper in the area of the Lot between the front property line and the front building line. If you plan add or to replace, consider planting some native or drought resistant plants and trees to accent your home. These plants can survive on less than 20 inches of water per year:

Shrubs: Rosemary, Mountain Sage, Yucca, Lantana, Lady Banksia Rose, Yaupon Holly, Burford Holly.

Trees: Texas Pistache, Chinese Pistache, Bur Oak, Shumard Oak, Mexican Redbud, Mexican Plum, Texas Red Oak, Mulberry, Cedar Elm, Vitex, Sumac, Desert Willow, Texas Mountain Laurel.

Architectural Control Committee News Re: (Article 3section 3.4)

The Board continues to hear from homeowners that the homeowner was "not aware" ACC approval is necessary for property improvements. <u>Any</u> new structure or structural change or improvement to an existing structure must be approved by the ACC <u>prior</u> to beginning construction. Failure to comply is an express violation of the deeds and restrictions we all received at the time we purchased our homes. <u>Claiming you do not know not knowing</u> the CC&R's or

failure to get clarification prior to construction is not a valid excuse. Obtaining a permit from the Town of Northridge does not supersede ACC authority to clarify or apply restrictions consistent with Northridge estates deeds and restrictions.

By constructing or making improvements that were not approved in writing, the homeowner subjects himself to a fine up to \$500 pursuant to 3.3(e), for each separate violation. Violations may include but are not limited to:

- -(1) construction without prior approval,
- (2) constructing a building that exceeds the approved square feet,
- (3) violating the setbacks specified in the CC&Rs when constructing a building
- (4) replacing a fence with a different type material

-These fines are secured by the assessment lien and subject to foreclosure; they are payable on demand.

In addition, the association can enforce the provisions of the declaration under section 5.2(d)(1) and (12) as well as section 9.2. Finally, if the owner refuses to comply and the Association has to file a lawsuit to enforce compliance, the attorney fees and costs related to the enforcement efforts are also secured by the assessment lien and subject to foreclosure, under section 6.5(b)(6) of the Declaration.

Many of you who attended the last annual meeting and town hall meeting expressed the desire to have the Board avoid unwarranted waivers and strongly enforce the CC&R's as written. To that end, the Board and ACC Committee have reviewed the deeds and restrictions and will renew their efforts to comply with your

request. We all must understand, if the Board decides to enforce against these express violations of the deed restrictions, then the costs to do so, along with the fines are subject to foreclosure, which is the ultimate leverage in enforcement of the Declaration.

Steps to Obtain ACC approval:

- 1. Log into Spectrum web site and complete ACC Request form. If you have questions or need additional help, you can email or call.
 - www.spectrumam.com or 972-992-3444
- 2. Attach necessary documents to your request. Be sure to include all of the details in your request listed on the web site. Once Spectrum receives the request, they will forward it to the ACC Committee. The ACC then has 15 days for review. If a denial is reached, they will explain why or will ask for additional information.
- 3. An email approval or denial will be sent to you as soon as all necessary documents are in place and the ACC Committee has had time to review them. The ACC review time does not start until all needed documents are received.

(Read CC&R's Article 3 section 3.3 for complete approval process)
